The Fiscal & Evaluation Committee advises the Commission on fiscal planning, budgeting, expenditures, and fiscal policies as well as the effectiveness of First 5 Humboldt's work. The Committee reviews our evaluation framework, annual data from program surveys, and provides feedback on how we can be most effective in achieving our Strategic Plan goals.

First 5 Humboldt serves the areas that are the traditional, ancestral, and present homelands of several indigenous nations, including the Hupa, Karuk, Mattole, Wailaki, and Yurok that make up Humboldt County. We encourage direct giving to Tribes and Native-led efforts, including the Wiyot Tribe honor tax.
